



Wildlife Veterinary Control Department

Main Responsibilities:

- Define, implement and supervise the surveylance programs and control of wildlife diseases that are transmitable to livestock and humans.
- Garante, at the interface, the implementation of prevention programs and control the transmission of wildlife diseases, ensure epidemiologic surveylance, and conduct surveys on wildlife diseases of importance to livestock and human health.


- Important to carry out a Rapid Assessment of the core and urgent veterinary issues facing the LNP;
- Carry a multi stakeholder workshop to discuss results of Rapid Assessment and develop a clear vision and understanding of where we want to go.

Rapid Assessment

 Conducted between 14th to the 30th of May 2007;

Key **drivers** identified in the field included:

- Fences, for example, the removal of Kruger National Park (KNP) fence,
- Livestock.
- **Resettlement** of communities and their livestock.
- •HIV and migrant workers,
- Lack of Resources within DNVS and LNP, including transport and fuel,
- · Lack of human capacity,
- Access to and availability of water, and conflict,
- Land Use planning in and around GLTFCA.
- Movement of livestock and livestock products,
- Zoonotic diseases, including public health issues such consuming unpasteurized milk,
- Human-Wildlife Conflict (HWC), including crop destruction.



WorkShop

- Conducted between 31st May to the 2nd of June 2007;
- Wide diversity of stakeholders (DNSV; DNAC; TFCA Unit; LNP management staff; LNP community representatives; Gaza Provincial Tourism Directorate; Gaza Provincial Livestock Services; SANParks; WCS; Academic Institutions; etc).
- •Key Question Identified:
- "How can we effectively manage wildlife and livestock within the GLTFCA, whilst preserving healthy ecosystems, improving livelihoods and sustaining economic benefits?"

THEN WHAT?

Main actions identified:

- Improve institutional coordination;
- Support Wildlife Veterinary Control Department;
 - Strengthen ToR of department;
 - Provide Training and Advisory Support (SANParks, WCS & SADC FMD Project);
 - Provide Equipment and Logistics Support
- Address wildlife /livestock /human health and disease transmission;
- Improve and monitor human wildlife conflict situation;
- Improve communication on resettlement of communities.
